Apple Tree School Supplies Needed

Even though schools are out for summer, Palatine Township is busy planning the next Apple Tree Campaign. Apple Tree, now in its 22nd year, collects and distributes new backpacks and school supplies to under-resourced children in our community. The program is designed to provide students, who are referred to us by local social workers, with school supplies needed to return to school prepared and ready to learn. Last year we were able to assist 1,300 students.

supplies will be collected July 12 through August 6 and distribution to the children will be August 9 through 13 at the Township Center. Volunteers are needed to set up & maintain collection sites, sort supplies, and to assist the children on distribution days.

Back To School Haircuts



In collaboration with the Palatine Lions Club (through the Lions of Illinois Foundation) and Illinois Retina Associates, S.C., pictures will be taken of the eyes of participants 18 years of age and older (10-17 with written parental consent) to check for retinal diseases, including macular degeneration. Diabetic Retinopathy is the leading cause of new blindness in adults in

America today. Early detection greatly enhances the visual prognosis and outcome for patients with all retinal diseases. This screening could save you a lifetime of darkness!

Hearing Loss Screening

In partnership with the Palatine Lions Club, we will be offering Hearing Loss screenings to all interested parties 18 years of age or older (10-17 with written parental consent). Take a few minutes to stop by to protect your hearing through this early alert system test.

Amplified Telephones for the Hearing Impaired

Trained representatives of the IL Telecommunications Access Corporation will help the hearing impaired do a "live" test on each of four amplified phones available FREE to qualified residents with a certified hearing loss and working land line telephone service. There are no age or income restrictions to qualify for this program.

Personal Blood Pressure Checks

Blood pressure tests will be conducted by a Palatine Rural Fire District emergency responder.

Highway Commissioner's Corner

Asphalt Paving of the Fielding Place and Lake Park Estates Subdivisions

This year the Asphalt Paving Project was awarded to Arrow Road Construction from Mt. Prospect. The entire subdivision will be repaved and deteriorated concrete curbs will be replaced. The cost of this project is approximately \$500,000. New gravel shoulders will be replaced as needed.



Road District purchases "Mini Excavator"



Prudent shopping on E-Bay enabled us to purchase a 2008 mini excavator with only a few hundred hours of use for 40% less than new. This like-new piece of equipment allows us to replace the roadway culverts without closing the road.

This spring we replaced all the metal culverts on the roads to be repaved this

year. By doing them ourselves we were able to save thousands of dollars and resolve some drainage issues at the same time.

Road District utilizes Geographic Information System (GIS) Technology for planning roadway improvements and asset inventory control.

Since GIS's inception in the early 1980's, communities have looked to digital maps to comprehend detailed data within and around their boundaries. It allows users to visualize information from such data contained in spreadsheets to reveal their relationships in order to make effective and efficient decisions regarding scheduling and maintenance. We were able to utilize a GIS program to create a base map for the entire Township which included right of way, municipal and parcel boundaries along with edge of pavement limits. Additional information and characteristics were gathered regarding pavement, signs and drainage areas. After our investigation and data retrieval for these particular objects, we were able to compile this information in a simple format and view them within Google Earth. By using a free program such as Google Earth, we were able to reduce the learning curve of new software while using a reputable program.

Your Town Fund and the Minimal Cost of Township Government – Assessor Terry Kelly, CIAO


Did you know that Palatine Township Government actually collects three separate taxes from you, the homeowner? These taxes are the Palatine Township Town Fund, the Road and Bridge Fund and General Assistance. The programs and services that are provided for the community are managed and paid for through these funds.

The Town Fund helps maintain many of the outstanding and award-winning programs at the Township, including the Apple Tree and Adopt-A-Family programs. The Township can keep the Town Fund costs to a minimum thanks to the hundreds of community volunteers and donations in our community. Other programs and services, such as the maintenance of the five historic

pioneer cemeteries in the Township, are also managed through this fund.

The yearly cost of the Town Fund on your tax bill, for a homeowner with a house valued at \$300,000 and receiving a standard homeowners deduction,

is only \$48.30. As you read more about the many worthwhile programs and services in this newsletter that are provided by the Township, I'm sure you'll agree that Township Government is a true bargain.



Rolling Meadows Historical 50 'S House Museum - Offers Something For Everyone -



What Is "Nostalgic" To One Is "Retro" To Another

Located one mile west on Central Road (3100 Central Road) from the intersection of New Wilke and Central Roads in Rolling Meadows, this museum was designed as a replica of the first ranch-style homes constructed in the community by Rolling Meadows founder Kimball Hill in 1953. Displays of donated historical documents, photographs, and furnishings of the 50's era are combined to create authentic interior spaces within the "home." Visitors, who may enter Wednesdays from 10:00 a.m. to 2:00 p.m. and Sundays from 1:00 to 4:00 p.m., feel as though they have been transported back in time to the home of a 1950's Rolling Meadows homemaker.

Self-guided tour books are available for groups of six or more. Entrance fees for school groups are \$1.00 per child and \$3.00 per adult for other groups. Donations are gratefully accepted from individual visitors. For additional information, please call 847-577-7086.

Election Update - Tuesday, November 2, 2010, is the next general election. Important races will be on this ballot including our U. S. Senator, Governor, State Representative, and other state and countywide offices.

Are you registered? - If not, come to the Clerk's Office during our regular Township Office hours (8:30 a.m. to 4:00 p.m. and Saturday 8:30 a.m. to 12:00 noon). We would be happy to get you registered to vote. You need to be a U.S. citizen and 18 years of age or older by November 2, 2010. You will need two forms of identification, with one showing your current address. The last day to register to vote is Tuesday, October 5, 2010.

Would you like to vote early? - Early voting will once again be available to Cook County residents. Palatine Village Hall and the Rolling Meadows Courthouse will once again be Early Voting Sites in our area, open from Tuesday, October 12, to Thursday, October 28, 2010. Any suburban Cook County resident may vote at these locations.

Fun Facts from Cook County regarding the February 2010 Primary Election Approximately 35,000 ballots were cast during the Early Voting period. This is less than 10% of the ballots cast for the election.

The Touch Screen Process was used by 70% of those casting ballots.



The Salvation Army Family And Community Services

The Salvation Army Family Services believes that the family is life's most important resource. The services we provide are tailored to strengthen individuals and families in consideration of their emotional, spiritual, social and material needs. We provide positive solutions for individuals and families by identifying more effective ways of coping with their personal problems and by developing and enhancing their personal relationships.

Our counseling program offers a holistic approach that encompasses the following life stages and/or crisis areas: personal/individual issues (children, teenagers, adults); parent/child difficulties; marital/couple conflicts; divorce-related issues; blended families; step-relationships; loss, death and separation; substance abuse; family violence; emotional, physical and sexual abuse; mood and eating disorders; self-assertion/self-esteem; crisis intervention for specific individual situations; advocacy and referral services.

We recently began providing home-based counseling to seniors who are unable to come in for counseling due to health-related issues. We are offering psychosocial and counseling services.

Our counseling program provides individual, marital, family and group counseling. All of our services are also available in Spanish. Each individual and family has specific treatment plans tailored to their needs, which can range from short-term to longer-term objectives. At times

we offer home visits on a limited basis for those clients unable to attend sessions due to physical limitations or other factors. Fees are based on a sliding scale and no one is refused service due to inability to pay.

We also offer Christian counseling services for those individuals who specifically request this approach to their personal concerns, as well as perpetrator treatment programs and family educational programming to build healthy family relationships.

Our staff consists of trained professionals with a Master's degree in Social Work and licensed by the State of Illinois. We are also a higher institution of learning and we provide internships to graduate students of Social Work and Psychology.

The Council on Accreditation accredits The Salvation Army Family and Community Services for Children and Families, Inc. and Child Care Association of Illinois. We are currently in the process of applying for another four years. This is a very rigorous and labor-intensive process.

This year we worked with 359 families from Palatine Township, conducting 807 counseling sessions.

At this time we would like to take the opportunity to thank the Palatine Township Board of Trustees for the financial commitment they have provided for 43 years in helping those who are in most need in their community. Together we are strengthening needy families.

Palatine Senior Center – Medical Assistance Screening

Low-income seniors may be eligible for a state subsidy of medication costs. Trish Abbey, Director of Social Services at the Palatine Township Senior Center, said this of the program: "I've seen many people save hundreds, if not thousands, of dollars by applying for the program Illinois Cares RX. This program pays for the premium and deductible of a Part D plan and lowers the co-pays." You, or a low-income senior you know, may be eligible for the program.

The SHAP (Senior Health Assistance Program) can help you find out if you qualify and help you to apply for the Illinois Cares RX program. The closest SHAP site is located at the Palatine Township Senior Center, located at 505 S. Quentin Road in Palatine.

Illinois Cares Rx is a state funded program that helps low-income seniors or the disabled access medications at a low-to-moderate cost. If you are on Medicare, Illinois Cares Rx covers most prescriptions as well as some over-the-counter drugs. If you are not on Medicare but are disabled, you may be eligible for Illinois Cares Rx "Basic" or "Plus".

As an example, individual seniors on Medicare with annual incomes under \$27,600, may be eligible. For further information, call Trish at 847-991-1112.

"Making the Most of Our Money"

In the spring of 2008 an area church created a way to minister to Palatine Township residents through an exciting program called "All My Money." Members of the Social Action Committee of the Countryside Unitarian Universalist Church had a mission to help people learn the sound principles of money management in a comfortable, nurturing environment.

Now called "Making the Most of Our Money," this ongoing program offers free classes in two, nine-week sessions each year. Participants meet at the church from 6:30 to 8:30 p.m. for an evening of fellowship and financial guidance. Starting in 2010 volunteers provided a delicious dinner for all participants and their families. Additional staff members taught money-related games and reading skills to the children while their parents attended the classes. Past participants have been clients of the General Assistance Department or those who have been involved in other Township programs. This unique, practical program has been so successful that Countryside Church was presented with a 2009 TOPS (Township of Palatine Service) Award in the category of "Outstanding Community Service Group."

Today, more than ever, understanding the role that money plays in people's lives cannot be understated. One might ask, "Can one person or one group really make a difference?" There is no doubt that the "Making the Most of Our Money" program has impacted the lives of those who have completed the program. A debt of gratitude is owed to Countryside Church members who are teaching classes, mentoring participants, giving lectures, and providing those excellent meals.
